Alameda County Fair Megan's Law Screening

The Alameda County Fair is committed to the public safety of all who attend the annual Alameda County Fair.

In accordance with the Alameda County Fair Policy, all entities conducting business on the fairgrounds property during the annual Alameda County Fair will be required to conduct screening of each of that entity's employees, agents, servants, volunteers, and/or independent contractors who will be performing job-related duties on ALAMEDA COUNTY FAIR premises. This screening must, at a minimum, include searches for sex offender registration. Entities will certify in writing that they have conducted the required screening, and will indemnify Alameda County Fair for any negligence arising out of or connected with their obligations pertaining to the required screening.

Any individual who is a registered sex offender and/or whose name appears on the California Department of Justice's Megan's Law database will not be eligible to work or volunteer on Alameda County Fair premises.
